With due respect, I have the honour to state that today i.e 02/03/2024 at @ 07.00 AM my husband namely Md. Meinul Haque (52 yrs) S/O Abdul Haque of House No. 219 Kshetri Makha Leikai, Kshetrigao, P.O & P.S- Porompat, Imphal East District went out from our residential house in his i10 Magna Gold color B/Regn. MN01X 2764 for normal work out at World Gym, near Krishna Premi Oil Pump, Yaiskul as daily routine but he did not return back timely. When we called up to his mobile numbers i.e 7005925696/7085593740/9089900262/8794516795 at @ 08.55 AM, his phone was found switched off. But we received a call from his number 9089900262 at 12.26 PM and he informed us that he was kidnapped by some unknown persons from Babupara, Imphal and kept in an unknown place, and threatened him to pay a sum of Rs 1.5 crore as a ransom amount by today itself.

It, is therefore, requested your good self to kindly take up necessary action to rescue my husband and save him at the earliest, and to take up further necessary legal action against the unknown culprits.
