

Sir,

With due respect, I have the honour to report that today i.e 3rd March, 2024 at @ 02.00 PM received information from private source that one Non-Manipuri will be proceeded to Dimapur, Nagaland from Tata Winger Parking, North AOC, Imphal near Public Toilet with some contraband items suspected to be ganja. The source report was reduced in writing and submitted a copy to Superintendent of Police, Imphal West District. Thereafter, under the supervision of Superintendent of Police, Imphal West I along with the police team of Imphal PS rushed immediately at Tata Winger Parking, North AOC near Public Toilet. On arrival at the Tata Winger Parking, North AOC near Public Toilet, the said non Manipuri was pointed out by the private source while he was standing with one luggage at the parking and immediately he was detained for verification. He identified himself as Anup Kamakar (30 yrs) S/O (L) Kamla Kamakar of Hara Kanta Sharma Bhawan, Dr. B Barooah Road, Ulubari, Kamrup Metro, Guwahati, Assam. On checking his luggage in presence of independent witnesses, 11(eleven) numbers of plastic packets suspected to have contraband ganja was found inside his luggage. The recovered 11(eleven) numbers of plastic packets suspected to have contraband ganja were properly weighed by using a weighing machine in presence of independent witnesses. The 11(eleven) numbers of plastic packets suspected to have contraband ganja is 11.379 KG including the plastic packet approximately without the weight of the luggage. The recovered item is listed under the ND&PS Act. So, the recovered 11(eleven) numbers of plastic packets suspected to have contraband ganja and one mobile phone VIVO X60 having phone No. 8472922304 were seize on production by Anup Kamakar (30 yrs) S/O (L) Kamla Kamakar of Hara Kanta Sharma



Bhawan, Dr. B Barooah Road, Ulubari, Kamrup Metro, Guwahati, Assam in presence of the independent witnesses namely Khongbaltabam Bikram (38 yrs) S/O Kh. Mangoljao Singh of Uripok Khumanthem Lekai, P.O & P.S Imphal, Imphal West District and Ningthoujam Somorendro Singh (47 yrs) S/O (L) N. Chaoba Singh of Kongpal Kshetri Leikai, P.O & P.S Porompat, Imphal East District by preparing a weighing and seizure memo at 03.10 PM. And he was also arrested from the spot at 03.20 PM. So, the arrested person along with the seized items are handed over to you for further necessary legal action.
