

Subject- Complaint report of break-in robbery and theft committed by unknown person at my residential house.

Sir.

I am submitting a complaint report of break in robbery theft in my house situated at old Lambulane Opposite G.P women's college. House No.54 on patta No.59 during the ongoing ethnic violence in the state.

The break-in robbery was committed in broad daylight in the month of February 2024, by unknown person and it was also witnessed by some local staying in the nearby areas who informed us on the 27th Feb'2024.

The looted properties are as follow:-

1. Kitchen cookware and utensil, fridge, dining table, kitchen Almirah Rs-320,000
 2. One double bed, two single bed, drawer, foldable Almirah, two TV tables, steel Almirah 3 door, two Godrej, wood Almirah, Desktop, laptop, office Chari, one double bed Dunlop, two single bed Dunlop, two shoe rack Rs-1470,900
 3. Sofa set, TV six side tables, TV table, 55 inch TV bed box Rs-358,000
 4. 8.5 kg washing machine Rs-18,500
 5. Water pump (three) 3 syntax, sewing machine, Gym cycle Rs-43,700
- The approximate amount of the looted properties is Rs-2,211,100
