

**Subject: FIR Report**

Respected sir,

I have the honour to report that, due to the violence erupted in Imphal Valley, 2023, we the Kuki-Zo community could not re-settle at Imphal Valley. All the residents and our church members left our residing houses at Zomi Villa North A.O.C Imphal on 6<sup>th</sup> May, 2023 for safety of our life since the law & order became more tense and worse that we could not be able to stay back leaving all our properties unattended.

It is unfortunate to learnt that, our Church building earlier named as Zomi Villa Independent Church which is a **registered body No.39/SR(IE)/2017** was forcefully intruded & occupied by unknown miscreants suspected to be the Arambai Tengol and looted all our Church properties and our pastor's Quarter household properties during the second week of February 2024.

**From the church, the following properties were looted:**

Sound system (Yamaha Co.), 80 arm benches, gas cylinder 8 nos, Plaster chairs 200 nos, Godrej Steel Almirahs 5 nos, Wooden beds 4 nos, Tables 8 nos, Computer sets (Epson) 3 nos, Dickchi, pots, plates, cups, Keyboard Yamaha, guitars 2 nos, electric guitars 3 nos, Wall curtains big sizes 2 nos, window curtains 20 nos, Geyser bajaj, Sintex 5 nos, dinining tables 10 nos, benches 50 nos, wall clocks 5 nos, stage pulpits 2 nos, boxes 4 nos, etc. approximate amount of = Rs.50, lakhs. (Rupees fifty lakhs).

**From the Pastor' Quarter, the following properties were looted:**

Fridge, Television, washing machine, Dinning Table Set, Sofa-set, Steel Almira, Almirah Wood, Bed boxes, 3 Beds, 2 Tables, Utensils, Cloths, Garments, Blankets etc. approximately Rs. 10 lakhs.

It is therefore, request you to take up necessary legal action as per the law of the land.
