Sub: Report on damage, loot and illegal Encroachment and Occupation of my Residential house at Zomi-Villa, North A.O.C, Imphal East by unknown persons.

Sir,

With due respect and regard, I would like to state the following few lines for your kind information and necessary action.

That, I along with my family members had left our residential house at Zomi-villa, middle Street, North A.O.C, Imphal East under the jurisdiction of Imphal Police Station on the 4th of May, 2023 for the safety of our life due to the ongoing ethnic crisis in Manipur.

That, in pursuance of the order of the Hon'ble Supreme Court of India dated 25th September, 2023 directing the State Government to ensure protection of the properties of Displaced Persons and prevent their encroachment, the Commissioner (Home), Government of Manipur had issued an order No.H-3608/2/2023-HD-HD dated the 16th October, 2023 in the name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioners and Superintendents of Police to implement the said directions of the Hon'ble Supreme Court of India.

That, in spite of the above stated orders, it has come to learnt on 29th February 2024 that our residential house at Zomi-Villa, middle street, North A.O.C, Imphal East had been illegally intruded by unknown miscreants by breaking doors and windows thereby looted all my household properties and ultimately occupied our house illegally since the **last week of February, 2024**. However, the exact date and time of the incident could not be ascertained. List of looted properties are hereby enclosed in a separate sheet/Annexure.

It is therefore, requested you kindly to look into the matter and take up a necessary legal action as per the law of the land.
