Sir,

I have the honour to report that on 13/4/2024 at about 10.30 am my son namely Phusam Farooque aged about 26 yrs chopped his elder sister namely Mrs Rani aged about 30 yrs W/o Abdul Noor of Mayang Imphal Bengoon Mayai Leikai by holding a dao. As a result, my daughter received injury on her person and evacuated to hospital for medical treatment. He also shot one round from his License Double Barrel gun attempting to eliminate his uncle namely Phusam Abdul Gaffar aged about 52 yrs. Luckily, there was no any casualties. However there is an apprehension for attempting to murder of my family members and nearby localities due to the act done my son. The said incident was occurred at my house.

It is, therefore, requested kindly to take up necessary legal action at the earliest.
