Subject: First Information Report against some miscreants posted notices in front of my building gate.

Sir,

I have the honour to submit the following grievances for your kind action. That due to sudden breaking out of violence, arson, killings, etc. in Manipur particularly in Imphal City me and my family members had to flee Imphal on May 4<sup>th</sup> 2023 to avoid being killed in the hand of Meitei mobs. Due to such sudden law and order problem we have to leave all our properties along with our house in Imphal city. Our building is located at the SBI ATM Building, Old Lambulane, behind Imphal West Police Station. Due to such unprecedented violent actions on our people, we could not even request anybody to look after our house and properties. Recently, it is learnt from reliable sources that some miscreants have posted a notes in front of our building gate that the building would be used for settlement of Refugees/Displaced persons from Churachandpur or so from the Meitei Community, which is totally illegal and unauthorized without the consent of the owner.

It may be mentioned here that the Government of Manipur, Secretariat: Home Department in its order dated 10<sup>th</sup> October, 2023 No. H-3608/2/2023-HD-HD signed by Mr. T. Ranjit Singh, Commissioner (Home), Government of Manipur has issued an order that the properties of displaced persons shall be protected and no encroachment by any person would be allowed and the Government of Manipur would ensure protection of all such properties. This was issued in pursuance of Supreme Court of India order in Special Leave Petition (Civil) Diary No. 19206/2023 (Copy enclosed).

In view of the above, you are requested to kindly take necessary legal action to remove the unauthorised notice placed and pasted in front of the building gate and to safeguard and protect our house and properties in Imphal. Any damage caused to the building and properties, the Government of Manipur will be solely responsible. Hence, Government of Manipur may kindly be requested to take necessary legal actions on such miscreants and take measures to safeguard and protect our property.
