



Sub: Report on illegal Occupation and robbery of my residence.

Sir,

With due respect, I wish to submit a complaint report in c/w the above-cited subject that I am a permanent resident of Old Lambulane, Imphal West, and have been taking shelter in Churachandpur due to the communal violence in the state since 3<sup>rd</sup> May 2023.

As per the information received, my house located at Old Lambulane, Opposite GP Women's College Main Gate, which is under construction has been subjected to rampant looting of all construction materials such as Cement, iron rods, bricks, etc, since last week of Feb 2024 i.e 26/02/2024. The thieves also looted my rented residence located on the 2<sup>nd</sup> floor of Accent Building located adjacent to my under-constructed house. The stolen movable properties include Furniture, electronic items, kitchen goods, clothes, building materials such as iron rod cement and brick, etc, and are estimated to cost approximately Rs 20,00,000/(Twenty lakhs). It is also learned that my residence has been illegally occupied by unknown persons.

It is, therefore, requested to evict the illegal occupants of my residence and take appropriate legal action against the thieves at the earliest.
