With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Gangte Tribe, which is a recognized tribe under the Constitution of India and residing at a rented house located at Thangmeiband, Senam Leikai, near Lamphellampak Gound, P.O. & P.S- Imphal West, Manipur. (Hemant - Hemanta) Imphal

That, on the 5th of May, 2023 at around 5:30 PM, with the help of a good friend belonging to another Tribe/Community, it came to my knowledge that a group of Meetei / Meitei miscreants suspected to be members of Arambai Tenggol and the locals in and around the area broke open the door of the said allotted Quarter and in the process they have vandalized and looted my household items/ movable properties, that includes;

1) Furnitures	Rs.1,52,000/-
2) Electronics & electrical	Rs.42,000/-
3) Kitchen items	Rs.35,000/-
4) Personal belongings	Rs.1,20,000/-
5) 1(One) Captain Bicycle	Rs.5,000/-
6) Misc	Rs.1,50,000/-
TOTAL AMOUNT	RS.5,04,000/-

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs. 5,04,000/- (Rupees Five Lakhs Four Thousand) Only, exclusive of the house.

That, the reason behind my late application is due to which I was at different states/remote areas, therefore, I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
