That, on the 5<sup>th</sup> of May, 2023 at around 5:30 PM, with the help of a good friend belonging to another Tribe/Community, it came to my knowledge that a group of Meeter / Meiter miscreants suspected to be members of Arambai Tenggol and the locals in and around the area broke open the door of the said allotted Quarter and in the process they have vandalized and looted my household items/ movable properties, that includes,
