1. That, I Thangminlen Haokip, Aged 29 S/o Haokholal Haokip belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India. Whereby, I had stayed as RENT at Canaan Veng (Owned by: Satkhojang Kipgen) P.S Imphal Police Station (IPS), Imphal East.

2. That, on 4<sup>th</sup> May 2023, at 10:00 am, huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our RENT House and in the process looted/vandalized properties.

3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.3.5 Lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at S. Molcham Village, Churachandpur.

So, I could not make the said report on time due to present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
