another G+4. That, due to ethnic/communal clashes in Manipur, all my family members
including all Tenents (Seven) families are leaving all houses and properties on the 4th May
2023 at 9:00 Am to 2nd MR Relief Camp, and unable to go my home till today.

That, as per reliable sources, all Shutter, Doors and Windows are broken and looted all
my properties (list enclosed) and illegally occupied on 19/01/2024 by marking AT at the Main
Gate by unknown miscreants.

It is therefore, request the Respected OC/Henglep may kindly register an FIR and take
up further immediate necessary action.
