schedule Tribe recognized under the constitution of India, Whereby, I am a Permanent resident of
Zomi Villa North A.O.C Imphal P.S Porompat, District: Imphal East.

2. That on 15th January 2024 at 9am, a huge contingent of Armed radical/ Meitei, Arambai Tengol
and Meitei leepun attack our village and in the process looted and Vandalized properties.

3. That the above said criminals with there in humane activities have causes me grave mental
agony. Notwithstanding the fact that, there unruly activities have made me great loss enormous
wealth estimated to be Rs 85 Lakhs.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us.
Henceforth, we are taking refuge at Lajangphai Village, Churachandpur.

So, I could not make the said report on time due to the present situation which unable me to do the
report.

I, therefore, request you to register on FIR and bring justice.
