

Subject :- **Report on Looting, Vandalism of household items, Documents and discrimination of Schedule Tribes.**

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I Bebem Chinneineng Haokip aged about 32 years D/o Thongkhai Belonging to the Any-KUKI Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a student pursuing my(M.ed)under Dhanamanjuri university. Staying at KBC working women Hostel located at Dewlahland, P. O-DM college & P.S- Imphal police station, Imphal west District, Manipur-795001.
2. That, on the 4th May, 2023. At around 11 AM, due to the ethnic violence in the state of Manipur, I left the said hostel to run for my life and took shelter at 2nd MR(Manipur Rifle) Camp imphal, in order to save myself from the angry mob attacking all the Kuki-zo Settlement in and around Imphal Valley, leaving behind my Hostel room at the above mentioned address along with all my household items and educational Documents.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony , the belonging which I have left behind was looted and vandalized. And incurred huge loss which may be estimated to be **Rs. 2,00,000 /- (Rupees two Lakhs) only** on 15th June, 2023 at around 10:00 am.
3. Fortunately, I managed to escaped from the criminals , and now currently taking refuge at M. Songgel Village Churachandpur .
4. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned address . And thus, I am filing the report lately today.
5. In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
