

Subject: Report on crimes of unlawful displacement, looting, vandalism and discrimination of
Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Any Kuki Tribe, which is a recognized tribe
under the Constitution of India and resident of Working Women Hostel, Room No. 9 & 11,
KBC (Kuki Baptist Convention, Deulalane, P.O.- DM College, P.S- Imphal & district-
Imphal West, Manipur.

That, due to the ethnic crisis in the State of Manipur, we deserted our above
mentioned hostel on the 4th of May, 2023 at around 11:00 AM, and with the help of a good
friend belonging to another Tribe/Community, it came to our knowledge that a group of
Meetei / Meitei miscreants broke open the door and in the process they have vandalized and
looted our household items/ movable properties on the 10th of June, 2023 at around 11:00
AM.

That, it may also be report that the said criminal activities have cause grave mental
agony and incurred huge lose which is estimated to be about Rs.7,50,000/- (Rupees Seven
Lakhs Fifty Thousand) Only, exclusive of the said hostel building.

The reason behind the late application is due to which I was with my family at different
remote areas for months, therefore, I humbly pray you to kindly register a ZERO FIR, and booked
the perpetrators under the relevant laws of our Country. And for which act of kindness I shall
always remain grateful to you. Thus, I am filing this application latley today.
