Subject:- First Information report on attempting to kill and ransacking, looting and torching down all my properties and house.

Sir,

I have the honour to state that on 4th May, 2023 at around 11 Pm some unknown miscreants belonging to Meitie/meetei Youth of Work Meitei Council (WMC), Meitei Leepun and Kangleipak Kanba Lup (KKL) and especially Arambai Tenggol numbering about 1000 members in all carrying sophisticated weapons like AK Rifles, SLR, 303 Rifles sticks and Iron rod enter our Village Colony Zomi Villa, North AOC, Imphal East and started ransacking, looting, torching my house. The list of my stolen/burnt down properties are shown in approximately values of **Rs. 1,70,00000/- (Rupees one crore & seventy Lakhs).**

Such a gruesome attacked and barbaric act on innocent civilians with an intention to kill all my family Members and looting my properties and torching my house without any reason is highly condemnable and totally uncalled for and tantamount to criminal act which calls for booking of the culprits under appropriate section of the Indian Penal Code. I, therefore, pray that the culprits may be apprehended and befitting punishment may be awarded as per law of the land at the earliest.

I seek your help and kindly request you to register my FIR in the subject matter.
Hope you will do the needful favourably at the earliest.
