I have the honour to report that, due to violence erupted on 3rd May, 2023, we the Kuki-Zo community could not re-settle at Imphal valley. So, I along with family members suddenly left our residing house at Zomi-Villa North A.O.C, Imphal on 6th May, 2023 for the safety of our life since the law & order became more tense and worse that we could not be able to stay back. We suddenly left all our properties at home and even a single item hadn't been taken out. We took a shelter at 2ND MR for 3(three) nights and later reached Kangpokpi and taking shelter at Relief camp and now staying in a rented house at Gunphaijang village Kangpokpi District.

It is learnt that, my residential house at Zomi-villa was intruded by unknown miscreants since the last week of November, 2023. The following household properties were looted by the unknown miscreants.

1. Kitchen equipment include; gas-stove(One), Gas- cylinder (5 nos.), utensils, 500 ltrs.(4 nos.), 1000 Ltrs. (2nos.)
2. Washing machine, fridge, TV (52 inches), Laptop (2 Nos.), sofa-sets.
3. Furniture include; wooden bed (5 nos.), almirah (5 nos.), dining sets, chairs, tables etc.
4. Traditional dresses include; wrappers, shawl, tie etc.
5. Traditional items include; necklace(6 nos.), big size Gong (2 nos.)
6. Gold jewelleryes include; necklace(6 nos.), ear-rings (5 nos.)
7. Cash; Rs. 7(seven lakhs)
8. Building construction materials include;
 - i) Cement – 100 bags (ii) Sand – 2 loaded trucks (iii) Water pump machine (iv) Generator (v) Iron cutter (4 nos.) (vi) 250 watt Fog light Bajaj (3 pieces) (vii) iron bars (6mm -90 kgs, 8mm-10 bundles, 10 mm-20 bundles, 12 mm-12 bundles, 16 mm- 9 bundles etc.

The total estimated cost of looted properties is approximately Rs. 1.5 crore. The delay of report is due to the unavailability of proper accommodation and facilities for settlement.

It is there requested to take up a legal necessary action as per the law of the land.
