

On 2<sup>nd</sup> week of December, 2023 from a reliable source I have learnt that my residential Quarters located at Imphal Central Jail, Qtr No. 21 N/Block, Old Lambulane Jail Road, PS-Imphal, Imphal West District has been ransacked and looted by unknown miscreants. The approximate loss properties worth Rs. 10 lakhs.

It is therefore requested you to take up a legal necessary action as per the law of the land.
