

Subject-First Information Report regarding looting of all my household properties by unknown miscreant from my residential house at Dewlahland, Imphal.

Sir,

With reference to the above cited subject, I have the honour to report that, on 3rd January 2024 I came to learn, that some unknown miscreant suspected to be a Meitei community looted my residential house at Christian Hospital Campus, Dewlahland, Imphal. They looted all my household properties. However, the exact date and time of looting my properties is not known to me. The approximate estimated value of my lost properties is about ₹ 3 Crores (Rupees Three Crores) only.

I could not report the incident to my concern police station as well as in time due to shifting from one relief centre to another and also due to the prevailing law and order situation in the state.

I, therefore, request you to kindly take up necessary action and book the culprits as per law of the land.
