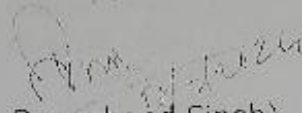

Today i.e. 17/03/2024 at 02.20 PM, received an information that on the same day at around 02.10 PM one person suspected to be a foreigner was loitering around Thangmeiband Yumnam Leikai, Imphal near Assembly Gate No. 3. Immediately, a team of Imphal-PS rushed at the spot for verification and the said foreigner was found near Assembly Gate No. 3, Thangmeiband Yumnam Leikai. On spot verification, he disclosed that his name is Mohamed Gamal Abdel Nasser, aged about 21 years, a citizen of Egypt. However, he could not produce any documents viz. Visa, Passport, ATM cards, Driving Licence etc. So, he was brought at Imphal-PS for further necessary legal proceedings.

Hence, a suo-mottu case under FIR No. 176(03)2024 IPS u/s 14 Foreigners Act, 1946 has been registered for investigation.
