

Today i.e. 17/03/2024 at @ 08.00 PM, I came across in social media a viral video of an interview session in YouTube by showing a deadly weapon suspected to be a Khukri in his neck where they stated that, "Manipur is a lawless society and there is no democracy in Manipur. The present communal crisis is the source of income of the CM Biren and the crisis is due the leadership of the present CM of Manipur, Biren Singh. In order to stop the crisis CM Biren must be change. If he is not change, we have to wait for his dead as he is not immortal. The present crisis is the business of CM Biren Singh. Drama is already started because of the upcoming election. During the interview they also stated that the security personnel are also mere spectator and they did not response or arrest anyone involved in killing of people. One VDF were also killed who went of destruction of Poppy plantation because he from Thoubal, from the constituency of former CM Ibobi." The viral video of the interview session in YouTube directly threats and insulted the life of Hon'ble CM of Manipur. Moreover, transmitting such hate videos at this juncture of crisis in Manipur provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state. Circulating such hate, false and alarming videos in the midst of the crisis also mislead the different communities which promotes hatred, enmity, revenge and retaliation at this juncture where the restoration of peace is being started between the different communities.

Hence, a suo-mottu case under FIR No. 179(03)2024 IPS U/s 153-A/307/500/505(2)/506/34 IPC has been registered for investigation.
