Report of damage, arson and theft to my properties in Sanakeithel, Imphal (Zero FIR)

Sir,

I am reporting the damage, arson and theft to my properties in Sanakeithel, Imphal due to the ethnic conflict that has started from 3rd May, 2023.

That, I have settled in Sanakeithel, Imphal since 1997 and have constructed a house too. That, when the ethnic violence erupted on May, 2023 my family was forced to flee and leave behind our house with all household items inside including my vehicles. That around 9:00 am of 4th May, 2023, we took shelter at CRPF camp of Lamphel, Imphal. Later, on I was informed by my neighbor over the phone that my house was ransacked, damaged, and all household items stolen.

We fled to Guwahati on 7th May, 2023 and stayed there till today. The circumstances did not permit me to file a complaint report early and hence I am filling this report after coming to Churachandpur.

I request you to kindly file a case under relevant sections of law so that loss of my properties in Imphal is compensated and my house building structure remains protected. I am enclosing the list of items stolen and destroyed by the radical meiteis for taking necessary actions.
