


Today i.e. 16/02/2024 at 7.20 pm received a reliable information that on the same day at about 7.10 pm one Diesel Auto bearing registration No. AS19AC/1810 driven by unknown driver plying from Imphal side towards Mayang Imphal collided with a Honda Pleasure bearing registration No MN01Z/9035 ridden by unknown rider which was plying from the opposite direction along Mayai Lambi road near Pravabati College, Mayang Imphal Thana Awang Leikai due to rash or negligent driving on the parts of the unknown drivers of the Diesel Auto and the Honda Pleasure. As a result of which two passengers of the Diesel Auto along with the rider and pillion rider of the Honda Pleasure received injuries on their persons and evacuated to Hospital for Medical treatment. The two involved vehicles were also partly damaged.

So, a Suo-Motto case under FIR No. 2(2)2024 MIPS U/s 279/338/427 IPC has been registered for investigation.


