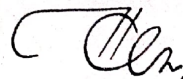

With due respect, I beg to state the following few
lines for your kind consideration and necessary action.

That Sir, on the 4th of May, 2023, at around 1:00 pm (IST),
unknown miscreants suspected to be Arambai Tergsol,
Kanglipak Kamba Lup, Maitei Leepua numbering about
1000 attacked my house at Phainon Verg, National Games
Village, Zone-I, near KBC Church, P.O./PS: Lamphel, Imphal West
District, Manipur and after looting all my properties, they
burnt down my house along with my Motor Cycle bearing
Registration No. MN-01-U-3187 (Royal Enfield Classic 500). The
approximate value of properties damaged is estimated to
be about Rs. 1.50 Crores.

Due to the prevailing situation of law and order in
the state, I was unable to file/ lodge this report at
an earlier date.

I, therefore, request your good office to look into the
matter and take necessary action.
