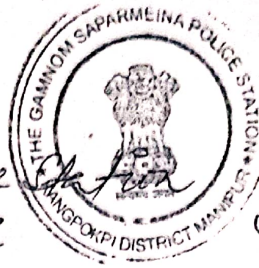

around 10 to 10:30 p.m., unknown miscreants suspected
to be Ahaambai Tengol Kangleipak Kanba Lup, Meitei
Leepun numbering about 1000 attacked my residence at
Hill View colony, House No. 07, National Games village,
Zone-III, London kids block near Methodist church.
They looted, damaged all my properties estimating
Value of about fifteen lakh (Rs 15,00,000/-).

Due to the prevailing situation and our
safety, I was unable to file/ lodge this report
earlier cause I was seeking refuge camp at 143
BN, CRPF camp, Lamphelpat.

I, therefore, request you to kindly look
into the matter and take necessary action
regarding the same.
