Sir,
With due respect and regard, I have the honour to state the following few lines for your kind consideration and necessary action.

On 3rd May 2023 at around 11:00 pm, unknown miscreants suspected to be Anambai Tingol, Kanglipak Kanka Lup, Meikie Lupur numbering about 1000 attacked my house at National Gamru Village Immanu Colony, Zone 1 and they looted and burnt down our house (1 storey pucca house), garage with 4 vehicle as follows:

- (i) Santro car - MN01X4829
- (ii) Alto K10 - MN06LX2766
- (iii) Vespa - MN01AH9502
- (iv) Activa - MN0108110

One pan dukan along with all the goods have been burnt down as well. The value of all our properties looted and burnt is estimated to be around one crore fifty lakhs rupees only (₹1,50,00,000).

I, therefore request you to kindly take up necessary and just action regarding this unlawful situation.
