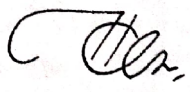

Leepun numbering about 1000 attacked my house
at National games village, Zone-2 K.B.C Church
Quarter, Imphal West District Manipur burnt down
our properties like Almirah, Bed Box, sofa set
and many others home and kitchen belongings
worth around 10-12 lakhs rupees.

That, I could not report the incident to
any concerned Police station as well as in time
due to the prevailing law & order situation.
