That, Sir on 3rd May, 2023 at around 10:30 PM unknown miscreants suspected to be Arambai Tenge, Langloipak Namba Lup, Mechi leepun about numbering 1000 attacked my house at Hebron Veng, Spring Villa, Phaijigang, Langol 80, PS Lamphel, Imphal West district Manipur and after looting all my property's dismembering my house is estimated to be about 32 (Thirty two Lacks) Lacks.

That I could not report the incident to any concerned police station as well as in time due to the prevailing law and order situation.

I therefore, request your good office to kindly take up necessary action in this regard.
