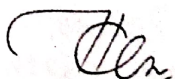

That, Sir, on the 4th May 2023 at around 7:30 PM unknown miscreants suspected to be Arambai Tengol Kangleipak Kamba Lup, Meitei Leepun numbering about 1000 attacked my Quarter number Type-II A-8 Langol Housing Complex, Lamhel West District Manipur PO/PS: Lamphel, and looted all my properties. The approximate value of properties lost/damaged is estimated to be about 20 Lakhs.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the State.

I therefore request your good office to kindly take up necessary action in this regard.
