Sir, With due respect and humility I the undersigned would like to state some few lines before you for your kind and sympathetic consideration besides necessary action.

That on the 3rd May 2023 at around 8:00 pm unknown miscreants belonging to Arambli Tengpel, Kangpokpi Karba hup and Meitei Leepun numbering about 200-300 stormed into my campus and destroyed, looted and burned down my house which included household items, furniture, land patras, books, electronic items, valuable items and other items worth approximately about 10 (ten) lakhs of 444 NIS Zou Vang, Lophal West, Gane Village Zone 1, Manipur -

I could not report the incident to my concerned police station as well as in time due to the prevailing situation in the state.

I therefore request your good office to kindly take necessary action in this regard.
