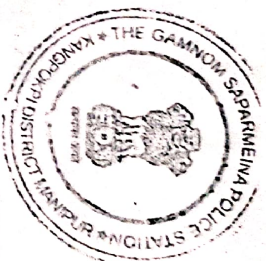

With due respect, I have the honour to state a few
line for your kind consideration and necessary action.

On the 4th May 2023 at around 5:00 AM unknown
miscreants suspected to be Ahambai Tenggot, Kanglipok
Kanka Lup Meitei Lepor numbering about 1000 or more
attacked our residence at Langget Housing Complex
T-II A (62) allotted in the name of Humirithang Kopper
located in Imphal West District, Manipur. Looted all
properties in my house including Two wheels (Dis-Engro.
MNO1AC3821) Television, Laptop, Printer, Washing Machine,
Desktop, Mattress, Mineral, Gas Stove, LPG Cylinder (5 No.)
all our clothes and Jewellery, Cash, Sofa Seats and
many more. The approximate value of properties lost and
damaged is estimated to be about 25 Lacks (Twenty Five
Lacks)

I could not report the incident to my concerned Police
Station as well as in time due to the prevailing law and
order in the state.
