With due respect, I the undersigned have the honour to report to your esteemed office for further necessary action hereafter.

That Sir, on fateful night of 3rd May, 2023 at around 9:00 pm unknown miscreants suspected to be Akambai Tengzoh, Kangleipak Kanbalup and meihei Leepun numbering about 500 attacked my residential Govt. Qtr. No. C/II/5-2HC at Langol, Imphal-4, under Lamphel Police Station and looted my properties including, Furnitures (Sofa set, Akroithak (steel & wooden), Dining Table, Kitchen Almorial, Bed, Bed Box etc) and other items like T.V, Refrigerator, Washing machine, Sinter along with my two wheeler Activa bearing registration no. MNO1AE-4437 worth Rs 9,00,000/- (nine lakh) only approximately.

Due to the prevailing situation, I could not report to my nearest Police Station i.e. Lamphel Police Station in due time.

In view of the above facts and circumstances, you are earnestly requested to look into the matter and take further necessary action in this regard.
