Sir, With due respect, I have the honour to state the following few lines for your kind consideration and necessary action. That, Sir, on 3rd May 2023 at around 10:30 pm, unknown miscreants suspected to be Arambai Jengol, Kangleipak Kanba Lup, Meitei deepun numbering about 1000 attacked my residence at National Games Village Zom-II B/213. They looted all my property worth about twenty lakh (₹ 200000) and burned down my two wheeler SG Activa blue colour, MN01AE5574 along with my important documents and files which were placed on the vehicle in order to save it from the mob attacked.

Due to the prevailing situation and our safety, I was unable to file / lodge this report earlier. I, therefore, request you to kindly look into the matter and take necessary action regarding the same.
