With due respect, I have the honour to state as a few lines for your kind consideration and necessary action.

That on the 4th May 2023 at around 11:30 AM unknown miscreants suspected to be Aowmbai Tengol Kangprip-ak Kanba Kup, Meitei Kupun numbering about 1000 attacked our house, number - 32, Chingmeingang West, Haining Likrai, Imphal West District PO/PS. Kanphel and looted and damaged my house and burnt down my car bearing Reg No - HND014N0-1359 (Honda Avage) and. Two wheels bearing Reg No - HND014J5233 (Hero Access).

The property looted/damaged is estimated to be about 30 Lakhs.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good office to kindly take up necessary action in this regards.
