Sub: Complaint/Report of illegal encroachment and occupation of my residential house of New Lambulane 1<sup>st</sup> Street by unknown persons suspected to be Pambei-led UNLF. *Imphal East, Manipur*

Sir,

With due regards, I am to state that I, the undersigned along with my family have left my residence at New Lambulane 1<sup>st</sup> Street on 6<sup>th</sup> May, 2023 due to the ethnic violence that erupted on 3<sup>rd</sup> May, 2023.

That, the Hon'ble Supreme Court of India passed an order on 25<sup>th</sup> September, 2023 directing the State Government to ensure protection of the properties of the displaced persons and prevent their encroachment.

That, in pursuance of the above-stated order, the Commissioner (Home), government of Manipur also issued an order No. H-3608/2/2023-HD-HD dated the 16<sup>th</sup> October, 2023 in the name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioners and Superintendents of Police to implement the said directions of the Hon'ble Supreme Court of India.

That, inspite of the aforementioned orders, I came to learn on 27/02/2024 that my house has been illegally occupied by unknown persons suspected to be Pambei-led UNLF as "U" has been marked on my gate, the evidence of which is attached herewith as Annexure-II. The exact date and time of illegal occupation could not be ascertained however suspected to be illegally occupied during the 2<sup>nd</sup> week of March, 2024.

In view of all the above stated facts, I request you to kindly take up necessary legal action.
