Sub: Report on illegal occupation or possession of my property/House located at New Lambulane 2nd Street, Imphal east. (old patta no. 986/1908 & New patta no. 729, village -26(A)-Nongpok Ingkhol) by unknown person.

Sir,

With due respect, I the undersigned, along with my family, would like to state the following for your kind information and necessary action.

That, I along with my family, had left our residence intact with household properties at New Lambulane 2nd Street on the 4th of May, 2023 for the safety of our life due to the ongoing ethnic crisis in Manipur.

That, in pursuance of the order of the Hon'ble Supreme Court of India dated 25th September, 2023 directing the State Government to ensure protection of the properties of Displaced persons and prevent their encroachment, the Commissioner (Home), Government of Manipur had issued an order No. H-3608/2/2023-HD-HD dated the 16th October, 2023 in the name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioners and Superintendents of Police to implement the said direction of the Hon'ble Supreme Court of India.

That, in spite of the above stated orders, it has come to our knowledge that our residential house at New Lambulane 2nd street had been illegally intruded by unknown miscreants by breaking doors and windows thereby looted all my household properties and illegally occupied since the first week of March, 2024. The matter came to light recently through a reliable source. However, the exact date and time of the incident could not be ascertained.

I, therefore, request you to kindly look into the matter and take up necessary legal action.


