**Subject :-** Complaint/ report of illegal encroachment and occupation of my residential house at New Lambulane 2<sup>nd</sup> Street by unknown persons suspected to be Pambei-led UNLF/ Meitei community

Sir,

1. With due regards, I, the undersigned is serving in **Indian Coast Guard under Ministry of Defence** and also presently posted at **Coast Guard Store Depot Porbandar** as **Officer-in-Charge**. My Family comprising of my younger brother and his family alongwith my younger sister had left my residence at New Lambulane, out of fear on 08 May 23 due to the ethnic violence that erupted from 03 May 2023. My residential address is as follows:-

2. That, the Hon'ble Supreme Court of India had passed an order on 25<sup>th</sup> September, 2023 directing the State Government to ensure protection of the properties of the displaced persons and prevent their encroachment.

3. That, in pursuance of the above stated order the Commissioner (Home), Government of Manipur also issued an order no. H-3608/2/2023-HD-HD dated the 16<sup>th</sup> October, 2023 in the name of Hon'ble Governor of Manipur directing all relevant Deputy commissioners and Superintendents of police to implement the said directions of the Hon'ble Supreme Court of India.

4. Despite the orders mentioned above, I have come to learn that my residence (ancestral house) has been encroached, illegally occupied by unknown person (Suspected to be Pambei-led UNLF/ Meitei community). Further, from reliable sources, house hold items have been stolen, looted and plundered by some unknown miscreants.

5. In view of the above, following is requested:-

- (a) Lodging of FIR against illegal encroachment/occupation of my residence.
  - (b) FIR against looting of household items.
- Any legal action as deemed fit.
