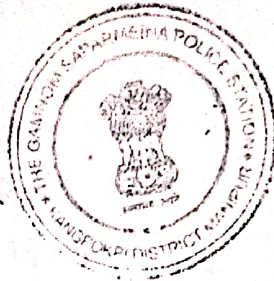

looted properties estimated to be around 50 lakhs.
