I have the honour to report that M/S Vicky Pharmacy License No. 9-X (F) DHS-2013 and License No. 10/QP-IE/2011 which was left unattended suddenly during the month of May, 2023 due to the sudden outbreak of violence in Imphal was looted by unknown miscreants by breaking doors and windows. The matter came to light on 14th March, 2024 by a reliable source. However, the exact date and time of the incident could not be ascertained and it is suspected to be happened during the **2nd week of March, 2024**. The approximate worth of looted drugs/medicines is estimated at Rs. 25,00,000/- (Twenty lakhs only).

It is therefore, requested to take up a legal necessary action as per the law of the land.
