Accordingly, a team of Porompat-PS led by me rush to the said area to effect arrest the unknown persons. On reaching at Tribal Market Lane No. 2 found that, two unknown persons were coming toward Tribal Market from New Lambulane 2nd Street on two four wheeler vehicle ie. Tata Mega XL bearing Regd. No. MN01AA-1583 and Tata Magic Ace bearing Regd. No. MN01W-2228 in a very suspicious manner loaded with some suspected stolen items. Immediately, the Police team stopped the two vehicle at Tribal Market for verification. On spot verification, the two unknown persons were identified as (1) Ningthoujam Chingkheinganba Meitei (26) s/o N. Bobby Meitei of Sugnu Napet a/p Lamphel Super Market Relief Camp driver of Tata XL bearing Regd. No. MN01AA-1583 and Khundrakpam Rojesh Meitei (24) s/o Kh. Temba Meitei of Gwaltabi (Yaingangpokpi) a/p Nongada Relief Camp driver of Tata Magic Ace bearing Regd. No. MN01W-2228. On further verification, they stated that the said household items were stolen from unknown abandoned houses of New Lambulane  $2^{n\alpha}$  Street areas. So, they were arrested and seized the two vehicle Tata XL and Tata Magic Ace along with loaded stolen items and brought at PS for further necessary action.
