Subject: First Information Report

Sir,

With due respect I have the honour to report that on 04-05-2023 at around 8.30 PM some current members of Erolsemba Youth Development Club (EYDC) led by the Club President, Secretary and executive members, suspected gang members of Arambai Tenggoland Meitei Leepun (leader Kourounganba Khuman Meitei) numbering about 100-200 persons with deadly weapons and arms had forcefully entered my house located at MS Zouvang, National Games Village, Imphal West, near Erolsemba Zoological Garden and attacked two security personnel of my son-in-law who were present there. The culprits look for me and as I was not there at that time they used derogatory and profane remarks against me with dire threat to my life, my family and my son-in-law's family as we belong to backward minority tribe of India and minority Christian religion. They started looting valuable properties such as Air Conditioner, Fridge, Mattress, Smart Television, Sofa Sets, all precious items kept inside Goddres or Almirah with the Almirah, Kitchen items like Oven, Gas Stove, Aqua water purifier, Induction etc. worth about Rs. 10,00,000/- (Ten lakhs rupees) from my house. Then, the accused persons had set fire to my house (photo enclosed) and it was totally gutted due to the fire which is worth about Rs. 1,50,00,000/- (one crore fifty lakhs). They had badly damaged one car-Maruti Zen, Saloon Colour, B/Reg-No. MN05A8798 (CHASIS NO: MA3EMD815001226, ENGINE NO: F10DN 3245881) worth about Rs. 6,00,000/- (six lakhs) which belong to one of the security personnel. The security personnel were brutally thrashed and beaten and were critically injured. The security personnel were almost killed but they had narrowly escaped. Had they not been able to escape both of them would have been murdered. I had informed the police for help but no police had come to my house. The same group had attacked my neighbours, arson their properties, and killed many innocent Tribals living at Imphal area. As I feared for my life I had hid myself, my family and run for our life. It is pertinent to mention that the same accused persons i.e. members of EYDC had come to our locality twice in the month of April, 2023 and threatened us with dire consequences.

I could not report on time due to shock, fear and tension done to me and my family. As I am utterly shocked from the attack I need medical attention and could not submit my report on time. Further, I had to run to save my life and my family from the life attempt of the culprits. Therefore, it is requested to kindly arrest the culprits and booked them as per law.
