The specifics of incident are as follows: specifies of incident: Residence of Mr. Minthang Suantak located at 2nd Street, New Lambulane, Near Eimi Place of incident: Residence of Mr. Manipur 705005

Times, P.O. & P.S. Porompat, Imphal East, Manipur-795005

Time of Incident: 1st April, 2024 at around 2pm

Brief history of the incident: On the day of May 3rd 2023, the ethnic cleansing perpetrated by armed radical groups Arambai Tangol and Meitei Leepun was in full force. On that fateful day, around 6 p.m., the armed groups attacked New Lambulane, causing widespread damage and destruction. At that time, I was staying in my Village. Haokhongching Village. When I was away, I left my three children to look after the house at New Lambulane. The armed Meitei mob scaled the walls of my residence and went in, but luckily, my children locked themselves inside the building house and before the mob could do harm, they were dispersed by the security forces. My three children were able to escape the horror with the help of some good people from the Neighboring place Hatta. Afterwards, the Assam Rifles came to rescue the people stranded there, and my three children were also rescued. They could not take anything with them except for some clothes and important documents. A car (Maruti Swift Dzire) and a bike were also left behind. The violence and the losses have caused immense hardship, and also the incident has traumatised us. To add to my misfortune, on 1st April 2024, a close acquaintance reported that everything in my house was vandalised and all my properties were stolen by unknown miscreants. It grieves me deeply that even with Central security forces and state forces being deployed to protect the area, such an act could occur.

In light of this I would like to reiterate the Supreme Court order passed on 25th September, 2023 directing the state government to ensure protection of the properties of displaced persons, as well as those which have been destroyed or burnt in the violence, and to prevent the encroachment of such properties. In compliance with the Apex court order the Government of Manipur issued an order vide. Order No. H-3608/2/2023-HD-HD dated 10th October 2023, stating that State government views the matter very seriously with utmost sensitivity and that the respective Deputy Commissioner and Superintendent of Police have been advised suitably to take action.

Therefore, In accordance with the State Government order, I earnestly request you to take appropriate stringent action against the perpetrators by registering a ZERO FIR under relevant sections of India Penal Code (IPC).
