Sir,

With utmost respect, the undersigned, I would like to apprise your good office of the following and take immediate action thereof.

That, we abandoned our homes and properties in Imphal on 4th May 2023 due to the communal violence in the state and sought refuge elsewhere for the safety of my family. However, as months passed by some unidentified miscreants set fire to our neighbor Mr. Haotinmang Vaiphei's house on the night of 4th January 2024 and the engulfing flame caught on our fencing wall leaving our house open for illegal activities and the following i.e 40 bundles of iron rods of various mm, 2950 pieces of bricks, 45 bags of cement, waterproof plywood 50(fifty) pieces, a drilling machine, cutter machines 2(two) nos, water pump 2(two) nos, 45 cement bags, 2(two) Sintex 1000 liters and wooden planks, etc were missing from my residence.

I couldn't report the matter in time as I was abroad and not sure of the extent of damage caused by the fire incident. Moreover, the person whom I requested to check out my residence was not allowed entry by the security personnel until recently when she intimated to me of the same.

It is therefore requested to take cognizance of the crime and take further necessary action as per the law.
