That, on the faithful night of 3rd May 2023 at around  
7:00 pm, unknown miscreant suspected to be Brambai Tengde,  
Kangleipak Kanba Lup, Meitei Keepan, Imoisemba Meitei & Youth  
Club, etc. numbering about 1000 attacked our church i.e Zou  
Christian Bible Church at Zou Veng, Phainom, National Games  
Village, P.O/P.S - Lamphelpat, Imphal West District, Manipur  
and looted, & destroyed and raged down, estimated to be  
around 80 lakhs.

I could not report the incident to my concerned  
Police Station as well as in time due to the prevailing  
law and order situation in the state.

I, therefore request your good office to kindly take  
up necessary action in this regard.
