commands attacked my residence at Newlambulane
3rd street, Chekhar, Imphal East and ransacked,
vandalised and burnt down my private place
along with (one) two wheeler (MNOIAM5815) and
(one) four wheeler (MNOIAG9078)
The estimated value of properties damaged is
around Rs 60,00,000/- (Sixty lakhs) only.
I, therefore request you to look into the
matter and take appropriate actions

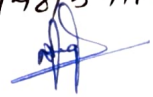
