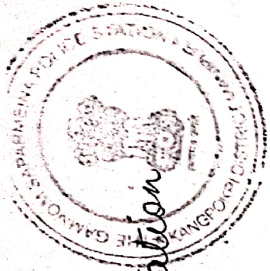

lines for your kind consideration and necessary action.

That on the 4th May 2023 at around 10 am an unknown  
miscreant suspected to be Drambai Tergol kanglipak  
anka lup, Meitei leupon numbering about 3000  
attacked our house, House no-35, Chingmierong  
west, Pukhui Achouka Napan, Ushal Mart opposite  
mpal west, 795001, P.O/PS: Lamphel and looted all  
the properties in my house. The appropriate value of  
properties looted and destroyed is estimated to  
be about 25 lakhs.

I could not report the incident to my concerned  
Police Station as well as in time due to the  
prevailing law and order situation in the State.

I therefore request your good office to kindly take  
necessary action in this regard.
