That, It has been almost a year now since we were forced to abandon our homes and properties in Imphal and flee to a much safer place, and that, I had not filed an FIR. But some unknown miscreants set on fire our neighbor, Mr. Haotinmang Vaiphei's house on the night of 4th January 2024 and the engulfing flame had partially damaged our extended building and our fencing wall, leaving it open for thieves and burglars to loot and pillage properties worth more than lakhs of rupees.

could not file the report in time as I was abroad with my family and the damage caused by the fire incident could not be ascertained till recently when our friend who is near the locality informed us about the same.

Therefore, I would like to register a complaint as of today. Thanking you.
