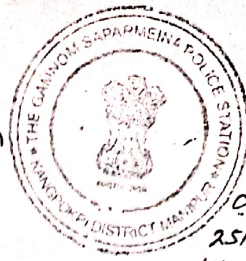

That, on the 4th of May 2023 at around 7:30 PM unknown miscreants suspected to be Arambai Tenggol Kangleipak Kamba Lup, Meitei Leepun numbering about 1000 attacked my quarter, number Type-II B-44 Langol Housing Complex, Imphal West District DO/PS: Lamphel, Manipur, and looted all my properties. The approximate value of properties looted/destroyed is estimated to be about 28 Lakhs.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I therefore request your good office to kindly take up necessary action in this regard.
