Report on crimes of unlawful displacement, looting, vandalism and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a resident of 1st Street, near Tribal Market, P.O. & P.S.-porompat, district- Imphal East, Manipur.

That, due to the ethnic crisis that erupted in the State of Manipur, we deserted our above mentioned rented resident owned by namely, (L) Dr. Holkhongam Haokip Wife (Thonglhing Haokip) on the 4th of May, 2023 at around 8:00 AM, and with the help of a friend belonging to a different community, it came to my knowledge that a mob of armed Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun, Meira Paibis along with the locals in and around the area attacked our locality, in the process they have looted all my household items/ movable assets and vandalized my house on the 20th of May, 2023 at around 4:30 PM.

That, my wife namely, *Nemvah Haokip* who has a legalized stall/shop trading on traditional dresses and other items located at the Ground Floor of Tribal Market, P.O. & P.S.- Porompat, district- Imphal East, Manipur, was also looted and vandalised by the above mentioned miscreants on the 4th of May, 2023 at around 10.30 AM which was informed by another trader who has a business at the above mentioned Market. That, I could not mentioned the ADC / Trade License No. as the documents is among the deserted items at the above mentioned rented resident.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose both on the *rented resident* and the *Stall/Shop*, which is estimated to be about Rs.21,00,000/- (properties of the resident) + Rs.2,50,000/-(Stall/Shop) = Rs.23,50,000/- (Rupees Twenty-Three Lakhs Fifty Thousand) Only in total, inclusive of the household items / movable assets and the above mentioned Stall/Shop.
