C.S Dag No. 2150 Village No. 26(A) measuring an area of 0.0303 Hectare by  
unknown person(s).

Sir,  
I, the undersigned along with my family have the honour to state the following few lines for  
your kind information and necessary action.

That, I along with my family had left our residence intact with household properties at New  
Lambulane 1<sup>st</sup> Street on the 6<sup>th</sup> of May 2023 for the safety of our life due to the ongoing ethnic crisis  
in Manipur.

That, in pursuance of the order of the Hon'ble Supreme Court of India dated 25<sup>th</sup> Sept 2023  
directing the State Government to ensure protection of the properties of displaced persons and  
prevent their encroachment, the Commissioner (Home), Govt of Manipur had issued an order No. H  
3608/2/2023-HD dated the 16<sup>th</sup> Oct 2023 in the name of the Hon'ble Governor of Manipur  
directing all relevant Deputy Commissioners and Superintendents of Police to implement the said  
direction of the Hon'ble Supreme Court of India.

That, in spite of the above stated orders, it has come to our knowledge that our residential  
house at New Lambulane 1<sup>st</sup> Street had been illegally intruded by unknown miscreants by breaking  
doors and windows thereby looted all my household properties estimated to be worth not less than  
75+ Lakhs moreover illegally occupied since the first week of March 2024. The matter came to light  
recently through a reliable source. However, the exact date and time of the incident could not be  
ascertained.

It is therefore, requested that you would be kind enough to look into the matter and take up  
necessary legal action.
